April Fools' Day – Wednesday, April 1st

ATTENTION FAMILY UNITS:

Spring is here! Please clean your units, and the outside of your units, from any clutter or debris that has piled up over the winter months. Also, **keep your porches clean and neat**. **Only outside furniture** is allowed on the porches. Garbage and recycling cans can be stored behind the unit but **do not** accumulate furniture, toys, etc. behind your unit.

LAWNMOWERS-FAMILY UNITS:

If the weather cooperates, the Maintenance Dept. will start putting the lawnmowers out at the Canaan St. site and the Russell Park site **near the end of April**. All tenants are required to **use the sign in sheet** that will be posted and return the lawnmower when you are finished using it.

Please use the lawnmowers carefully! Do not hit or run over anything that is in your grass. You may be held responsible if you damage the lawnmower.

Remember, it is your responsibility to cut your grass. If the contractor cuts your grass, you will be charged **\$25.00-1st time, \$35.00-2nd time, \$45.00-3rd time, The 4th time will be \$50.00 and you will be sent an intent to evict.**



INSPECTIONS:

The CHA will be doing inspections in the **John St. development** during the month of **April**.

Inspections will be done between the hours of 9:00 AM and 4:00 PM. If you are not home at the time of the inspection, we will enter your unit and leave a notice stating that the inspection was performed.

Also, remember to **bring your rent statement** with you when paying your rent.

CHANGES IN INCOME:



Tenants **MUST** report all changes in income or new employment within 10 days to our office. HUD reports to us any discrepancies in wages, which will result in a back charge if not reported in a timely manner. You can find a change in income form on our website, email us, or bring in the verification to our office.
